

Your referee should be a professional person or a person of good standing in the community. There is a full list on our website that gives examples of the type of person that would be suitable eg, Doctor, Teacher, Lawyer, Bank Manager, Elected Councillor, Vet etc.

Your referee must not be related to you by birth or marriage, be in a personal relationship with you or live at the same address as you.

Section 1 – Complete this section if your referee **knows** you.

Section 2 – Complete this section if you are having your documents verified by someone who **doesn't** know you.

1 Take this form to your referee, a person who knows you, photocopy your original documents from the list over the page at point 3, show the originals to your referee and ask them to sign the copies to confirm they have seen the originals. Your referee must also sign the back of one of your photographs as worded below.

2 If you do not know anyone personally who can act as your referee you may present **photo ID only (Driving Licence or passport) and one other piece of ID from the list over the page at point 3**, to a person who has agreed to act for you as previously mentioned above and ask if they will verify your documents and application. Please remember that agreeing to help you in this way is at their discretion. Please photocopy your original documents and ask the person to sign them stating they have seen the originals and to sign the back of one of your photographs, "I certify that this is a true likeness of Name of applicant".

What is it?

VALIDATE UK is a voluntary proof of age card for everyone, it aims to ensure that age restricted products are only sold to those legally entitled to buy them; it also helps those who may look younger than they are to prove their age. PASS is the UK Government's approved standard for Proof of Age.

This is what you need to do

1 You will need two good quality colour identical head and shoulder passport sized photographs with a **plain** background. Your head must be in the middle of the photograph. *Poor quality images will be rejected!*

- No sunglasses
- No Hats
- No face painting
- Photo must be facing forwards
- Photo must be a true and current likeness of you

2 You will need to have either section 1 or 2 completed on the authorisation page, see over. Your referee completes Section 1 if they **KNOW** you or use Section 2 if you are having your documents and application verified by someone who does **NOT KNOW** you.

3 You have to photocopy 2 of the following, **AND show the originals to your referee who must sign the copies which must be sent in with your application. DO NOT send originals. If you know your referee you may use any two of the following;**

- Birth Certificate
- Copy of back page of passport with photo
- Photo Driving Licence
- Medical Card
- UK Armed Forces Card

If you don't know your referee, ie you are having your documents and application form verified as in section 2 over the page then you must have one piece of photo ID plus one other from the list.

4 Payment is by cheque or postal order to **VALIDATE UK**.

If you have a problem supplying any of the above PLEASE CALL the VALIDATE UK office for advice.
